A COVID-safe transport network: Park - Walk - Ride at Moore Park

Transport for NSW is urging customers to avoid peak hour on public transport and consider other ways of getting around to help reduce the spread of Coronavirus.

Last week the NSW Government announced its <u>plan</u> to provide a COVID-safe transport network.

As part of this plan and to keep commuters safe, the government is ensuring there are plenty of safe and efficient options to get people moving throughout our State during the pandemic.

As social distancing measures begin to ease, commuters are encouraged to utilise park, walk and ride options that are available to ease congestion while people make their way back to work. Special event-style parking arrangements will be in place at Moore Park for people who are able to drive to work. Other locations will be rolled out soon.

Additional point to point transport pick up locations have been made available around the Moore Park precinct. The general public that choose to use Moore Park parking area will be encouraged to walk or cycle to the city, with Light Rail, bus, and point to point transport options also being available.

Passengers wishing to hail a taxi, can do so safely from Errol Flynn Boulevard. For booked services including rideshare pickups and drop offs, Driver Avenue is the safest and most suitable location to do so.

Vehicle Sanitisation Station roll-out

The Point to Point Transport Commissioner and Transport for NSW have been rolling out government-funded, complimentary vehicle sanitisation stations at



locations throughout metro and regional New South Wales. The first two sites are at TAXITECH in Alexandria, and Dubbo Buslines in Dubbo, more sites will be announced in the coming weeks.

This is a complimentary service for all point to point transport passenger service providers entitling drivers to one sanitisation, per vehicle, per day to help minimise the spread of illness and assist with maintaining driver and passenger safety.

Eligible vehicles for sanitisation include taxis, hire vehicles, rideshare vehicles, and community transport vehicles.

Wheelchair Accessibility Taxi Loan Scheme

In response to the changes in the way people are travelling during the Covid-19 pandemic and in recognition of the role Wheelchair Accessible Taxis (WAT) play in delivering essential transport services for vulnerable members of the community, Transport for NSW is deferring payments on all Wheelchair Accessible Taxi Interest Free loans. For loan recipients, payments will be \$0 for April, May and June 2020.

A further review of the pandemic restrictions and the impact they are having on the way people travel will be undertaken in mid-June to determine if any further deferral of loan repayments is required. All WAT Interest Free loan agreements will be extended by the length of the postponement period.

Each loan recipient has been contacted by Transport for NSW and provided advice on how this postponement affects their loan. A process has been developed for any loan recipients wishing to continue to make their usual payments during this period. Taxi plates on hold

Drivers who would like to put taxi plates on hold will need to visit a Service NSW Centre to conduct the on hold transaction. Before visiting Service NSW, drivers should make sure all documentation has been provided to conduct the transaction.

Taxi industry assistance package

On Friday the Treasurer, Minister for Transport and Roads and Regional Minister for Transport and Roads, announced a \$12.6 million stimulus package for the taxi industry.

It is important to note that applications for the \$2900 stimulus package through Service NSW do not open until June 2020.

Waiver of first \$500 of 2018/19 authorisation fees

All authorised service providers will receive a waiver of the first \$500 of authorisation fees per service provider for 2018/19 financial year. In addition there will be no CPI increase to the authorisation fees for financial year 2019/2020. Instead, the fees payable for the financial year 2019/2020 will be the same as those specified for financial year 2018/2019.
